This template can be used for multiple purposes:

- It enables schools to effectively plan their use of the Primary PE and sport premium
- It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium
- It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make **additional and sustainable improvements** to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

**The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated [Primary PE and sport premium guidance](#).**

The Primary PE and sport premium guidance, outlines 5 key priorities that funding should be used towards. It is not



necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards.

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Schools must also outline what the impact this funding has had on pupils' PE and sport participation and attainment and how any spending will be sustainable in the future. **All funding must be spent by 31st July 2024.**

The Department for Education has worked closely with the Association for Physical Education (afPE) and the Youth Sport Trust (YST) to develop this template and encourages schools to use it. This template is an effective way of meeting the reporting requirements of the Primary PE and sport premium.

## Review of last year's spend and key achievements (2022/2023)

We recommend you start by reflecting on the impact of current provision and reviewing your previous spend.

Playtime leader training and support	Play leader training developed team building and confidence skills amongst the children who have been trained and has supported an increase in physical activity during playtimes and lunchtimes. The children have improved their physical activity and their social and communication skills as they interact with children from other year groups effectively. Having a more structured playtime and lunchtime has had a positive impact on children's correct behaviour choices and positive engagement in physical activity.	Children were more engaged in physical activities in the playground. Next focus is to embed this and for this to rely less on external members of staff.
Weekly clubs	Children will engage in a variety of different team building sports and activities. This will support behaviour and attendance in school.	Children engaged in regular after school activities, including disadvantaged and children with SEND.

Children were involved in competitive sports festivals.	The health of our children is incredibly important with growing levels of obesity and the temptation to stay indoors greater than ever. Making sure children have dedicated time where they are active, exercising and enjoying being outdoors is essential to keeping them healthy. By taking part in the competitive sports activities children experienced being active, with expert coaching so they are engaging in the right kind of exercise for their age group.	Children engaged with the events, and they loved taking part in events such as football/cricket.
Successful sports day	Children were engaged in a successful sports day which was observed by parents. Staff and children were put into houses, and they competed for more points for their teams. The winning team was awarded a house cup.	Our sports day was a success, and we had positive feedback from parents and children.  Our children took pride in their team, and they developed their teamwork and resilience.
Active playground	We have got a working active playground which is organised and well resourced. Children are thoroughly engaged in this playground they have lots of different activities to choose from.  The number of incidents on the playground has decreased due to the overall participation in sports.	The active playground scheme has contributed to a calmer and more engaging playground for pupils.

## Swimming Data

Meeting National Curriculum requirements for swimming and water safety.

Priority should always be given to ensuring that pupils can perform safe self-rescue even if they do not fully meet the first two requirements of the National Curriculum programme of study

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	61%	
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	39%	
What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?	50%	
If your schools swimming data is below national expectation, you can choose to use the Primary PE and sport premium to provide additional top-up sessions for those pupils that did not meet National Curriculum requirements after the completion of core lessons. Have you done this?	Yes	We have now increased the number of year groups accessing a block of swimming lessons each academic year. Children will now go swimming from Year 2. Over time, this will have a positive impact on the number of children achieving these criteria.
Have you provided CPD to improve the knowledge and confidence of staff to be able to teach swimming and water safety?	No	Swimming is currently taught by swimming teachers who are not school staff.
